NOTICE OF PROPERTY TAX INCREASE

The City of Lyons has tentatively adopted a millage rate that will require an increase in property taxes by 2.36 percent.

All concerned citizens are invited to the public hearing on this tax increase to be held at Lyons City Hall on November 5th at 6:00 PM.

Times and places of additional public hearings on this tax increase are on November 5th at Noon and October 29th at Noon.

This tentative increase will result in a millage rate of 3.89 mills, an increase of 0.00 mills. Without this tentative tax increase, the millage rate will be no more than 3.89 mills. The proposed tax increase for a home with a fair market value of \$100,000 is approximately \$155.60.
